I agree to indemnify (that is, to pay any losses, damages or costs incurred by) the competition, the management, End of Hunt Farm, Inc., the affiliated associations, and to hold them harmless with respect to claims for harm to me or my horse and from any harm caused by me or my horse to others, at the competition. If I am a parent, guardian or trainer of a junior exhibitor, I consent to the child's participation and agree to all the above provisions and agree to assume all of the obligations of this release on the child's behalf. Every exhibitor or his/her agent and horse owner must sign an entry form. In the event of his/her failure to do so, his/her first entrance into the grounds shall be construed as acceptance of the rules of the show, the affiliate organizations and End of Hunt Farm, Inc..
